#### ZEDAL - your modern and future-proof tool

Cross-border waste shipments are playing an increasingly important role in a Europe that is growing together, but also worldwide.

ZEDAL provides the necessary forms and workflows in accordance with all relevant legal standards as a web application. The forms can be conveniently filled out, saved and archived on screen with master data support and plausibility checks.

The forms and other documents can be used in the further process as a paper printout, by fax, by e-mail and electronically, with or without a qualified digital signature. The aforementioned communication channels can be used in a mix, whereby each sending and receiving process is logged with the dispatch entry and delivery status.

For the electronic form, ZEDAL currently uses eTFS, the de facto standard in Europe. Once the new Waste Shipment Regulation comes into force on May 20, 2024, the EU Commission will define new data formats and communication protocols. ZEDAL guarantees that these will be supported.

#### **Basic costs**

The basic costs cover the unlimited creation and saving of the «Notification» form as well as all professional and technical support costs. The basic costs are levied from all ZEDAL participants (exporters, producers, transporters, importers, recycling / waste disposal firms, brokers, dealers, authorities) annually and in advance for the period of one year.

#### Transaction costs – quantity scale

The settlement of the «movement document» form occurs on a process-dependent basis and is calculated to exporters/ producers/ recycling-/ waste disposal firms/ brokers/ dealers, calculated according to the following quantity scales. Authorities and transporters are free of transaction costs, unless they create or post documents in ZEDAL themselves.

The scale values are offset monthly.

Possible corrections to the scale or other corrections such as those due to cancellations occur with the monthly invoice for the past months of the calendar year. Cancellations of movement documents which are not used are taken into consideration for the settlement of the corresponding calendar year by 31.12.

#### Fax service costs

The technical setup and maintenance of the fax service is satisfied with the basic flat-rate costs.

The actual telephone charges are payable in advance. For this purpose, an advance payment account is set up per participant which they then complete in advance.

The settlement takes place according to the price list of «Deutsche Telekom» valid at the time of the shipment, plus a handling charge of 5%. The settlement takes place monthly.
